The inauguration session ended with a vote of thanks by Samhita Ray, the State Project Coordinator of State Project Unit.

At the end of the inauguration session, there was Technical Session I – "Overview of UNEP-GEF Project & Role of Media." The session was chaired by Dr. A.K.Gupta, Shri Ishwar C. Poojar, Dr. Prakash Nelliyat, Dr. B.K. Kilkdar, Shri J.S.Pathan & Dr. Rupam Mandal. The gathering was addressed by Dr. Ishwar C Poojar. His presentation in the technical session further elaborated the concept of Access and Benefit sharing provisions and the role of media in creating awareness about this programme.

Technical session II – "Economic valuation, interaction with BMCs & private sectors" was chaired by Dr. A.K.Gupta, Shri Ishwar C. Poojar, Dr. Prakash Nelliyat, Dr. Rupam Mandal, Shri Nalinikanta Chakraborty, Shri Achintya Sinha & Shri Khuswant Singh. Thereafter, Dr. Prakash Nelliyat made a presentation elaborating the economic valuation methodologies and various case studies.

This was followed by Technical session III, an interactive session with the BMCs and other participants present there. In this session Shri Achintya Kumar Sinha presented a paper on "Langi", a magnificent herbal rice beer of Tripura. This was followed by an extempore speech by Dr. Rupam Mandal who shared his experiences working with the UNEP-GEF Project in WestBengal. Mars Socio Welfare Society, Kanchanpur, has shared with the audience their achievements made so far. Shri Rajesh Roy from Dhalai gave a presentation on traditional methods of treatment for different diseases. BMC members have also shared their views regarding different bio resources and their traditional uses.

The program ended with a narration on future road map from the Member Secretary, Tripura Biodiversity Board who also mentioned that successful execution of the project shall add a new chapter in the conservation ethos where local "Owners" of resources who are the poorest will get their due monetary and non-monetary share from the rich commercial "Users" which in turn will lead to the poverty alleviation of the state.
