## **TERMS & CONDITION**

## FOR PREPARATION OF PEOPLES BIODIVERSITY REGISTER (PBR):

- The PBR has to be prepared as per the standard guidelines available in the website of National Biodiversity Authority (NBA) & TBB. Sample can be seen in any working hours in the TBB office.
- The PBR has to be prepared in consultation with the local villagers/ traditional healers etc. for the blocks alloted.
- Effort must be taken to document the bio-resource in (Agricultural eco system, wetland eco system, Forest eco system) including rare, threatened, endangered etc. and have potential importance in terms of trade use in Pharmaceuticals Company etc.
- Tentative financial allocation for survey/ documentation/ printing etc. of against each PBRs of the block is about Rs 1,00,000/- (One Lakh).
- Softcopy of each PBR has to be shared with TBB for further publication.
- The PBR has to be submitted within 30 days from the date of issue of official work allotment.

## **Payment Condition:**

- 25% of the funds will be given as start up fund on furnishing Bank Guarantee & MoU.
- Documents to be submitted alongwith the application.
  - i. ITC/ PTC and GST No.
- ii. Registration No of the Firm/ NGO
- iii. Draft for Rs 10,000 in the name of "Tripura Biodiversity Board"
- 35 % of the cost of PBR preparation will be given after the draft PBRs are approved by the Expert Committee Members of TBB.
- 40 % on submission of draft.
- Income tax etc. will be deducted from the bill as per guidelines.
